# St. Mary Parish Sheriff's Office 2015 ANNUAL REPORT



In 2015, the St. Mary Parish Sheriff's Office became an accredited law enforcement agency through the Commission on Accreditation for Law Enforcement Agencies (CALEA). We accomplished this goal in the first 4 years of our term. Attaining accreditation in such a short time is something that very few agencies have done and is unprecedented in this state. It is a testament to the hard work of deputies who believed in our vision to improve this office. Accreditation has strengthened the infrastructure within our divisions and brings us to a higher standard of accountability. It gives transparency and has opened new channels of communication giving you easier access to Sheriff's Office services and information. The checks and balances now in place ensure that this office will maintain high standards of service well into the future.

From the first call for service, deputies and detectives swiftly and aggressively pursue leads in all investigations. By cultivating this determination and executing other positive patrolling practices we saw a drop in crime in 2015.

Decreases in tax revenue have had a profound effect on your Sheriff's Office. In 2012, I began to look at what we could do to offset a potential economic downturn. That year, I began streamlining services and implementing cost saving measures that have made this office more efficient. At the St. Mary Parish Law Enforcement Center, I reduced the cost of inmate transports to hospitals through the introduction of telemedicine and by contracting with skilled medical professionals who work on site. A food service contract significantly reduced the cost of inmate meals. And I reduced cafeteria staff by using inmate labor to prepare and serve food.

In 2016, we know that more difficult financial challenges are on the horizon. The accreditation process has shown us that we can work in more efficient ways with fewer personnel. We will meet with local, state, and federal agencies to seek out additional funding. We will also continue to research grant funding that has provided means to acquire equipment and other resources at a reduced cost. As the people we serve continue to feel the impact of the changing economy, I am committed to looking for new ways to streamline operations while maintaining the highest level of law enforcement services for you.

I am blessed to have the continued support of the residents of St. Mary Parish. I promise to build upon that trust and confidence. Thank you for supporting the law enforcement professionals here at the St. Mary Parish Sheriff's Office.

Dispatchers received 1,172 medical emergency calls. Deputies respond to medical emergencies to secure the scene for medical personnel.

Deputies provided 108 escorts for funerals, security, and parades.

While on patrol, deputies located and secured 251 open doors and windows at residences and businesses.

**C** Deputies conducted 360 welfare checks.



Deputies responded to 408 animal complaints, 43 of which involved black bears. Other calls involved cats, dogs, cows, horses, ducks, alligators, goats, deer, snakes, opossums, a bat, a buzzard, and other miscellaneous birds.

Located in Centerville, LA the St. Mary Parish Law Enforcement Center is a 320 capacity facility owned and maintained by the parish. It is operated by the Sheriff's Office and houses offenders from law enforcement agencies across the parish. Our responsibility to inmates goes beyond basic care. Offenders are given opportunities to better themselves before re-entering society. High school equivalency diploma and transitional work programs allow inmates to work while incarcerated. A portion of the money they earn pays for the cost of their incarceration. Also, child support (if applicable) is automatically deducted from their pay.

### **MOTOR POOL**



The on staff mechanics at the Sheriff's Office motor pool provide routine main-🚺 tenance as

well as major repair work to patrol units.

Motor pool mechanics also service Sheriff's **Office support vehicles** such as the command center and off road vehicles. Performing these services in house reduces vehicle related costs.



## **BACKGROUND CHECKS**



The St. Mary Parish Sheriff's Office conducted 1,046 background checks in 2015. Background checks for individuals are conducted at the Franklin dispatch office from 8:00 am

to 4:00 pm, Monday through Friday. A valid picture ID, social security card (no photocopies), and \$15 money order are required.

**ST. MARY PARISH SHERIFF'S SHOOTING RANGE**

It is located off the US Highway 90 service road in the Franklin area. From the west, take the service road at Chatsworth Road and Willow Street. From the east, take LA Highway 317 to Alice C Road and turn left onto the service road. There are no fees to use the range.
